January 12, 2010

- Mr. Lozano distributed the revised calendar for January - July.
  - Battle the Bands tickets available for sale by the Band Directors. Battle of the Bands will be on Thursday, April 22<sup>nd</sup>. Reserved seats are \$5 each. General admission tickets are \$4.00 each. Parents may start sending money with their student to purchase tickets.
  - New uniforms were presented to those in attendance. Uniforms will be presented to the board tomorrow, 1/13/10 for approval.
- Laura Evans, 1<sup>st</sup> VP – Thank you letter was presented to Mr. Harris for his generous donation of \$2,500 to go towards the purchase of a new trailer. Trailer has already been purchased.
  - Mr. Harris thanked the parents for their attendance and involvement. He advised that he was working to have concrete added by the portables to make it easier to transport the trailers.

- Laura Evans, 1<sup>st</sup> VP –
  - Fundraisers – band calendars are in and ready to sell. Calendars are \$7 each. Sell 6 calendars and get 1 free. Calendar order forms were available at the meeting. If parents need a copy, order forms will also be available on the Mustang Band website.
  - Rummage and plate sale are scheduled for March 27<sup>th</sup>. Rummage sale will be from 9:00-2:00. Parents should start sorting their donations of clean clothing, gently used shoes and other reusable household items. Storage for rummage sale items has not yet been determined. Plate sale for March will consist of chicken, sausage, rice and beans. Students will each be required to sell 5 tickets at \$6 each. Tickets will be distributed to students by early February. All money for plates will be due by the first week of March. This allows ample time for the students to sell a minimum of 5 tickets.
- Letty Lozano, Treasurer, went over the financial report. Financial report beginning balance was \$7,188.49, with deposits totaling \$11,964.50. This totaled \$19,152.99.
